

# Chief Public Defender

Kalamazoo Defender is a non-profit organization established for the purpose of representing the adult indigent population charged with a crime within Kalamazoo County. It is Kalamazoo County's Public Defender.

Three things distinguish Kalamazoo Defender from most public defender offices in Michigan: 1) It is a tax-exempt non-profit organization, independent from County government; 2) It is governed by a board of citizens with legal, judicial, medical and social work experience; and 3) It represents a "holistic" model of representation, integrated with Kalamazoo's many human service organizations in order to attend to the whole client, beyond the strict confines of a particular criminal charge.

Kalamazoo Defender's mission is rooted in the conviction that poverty and various forms of discrimination put our clients on inequitable footing within and beyond our criminal justice system. Our job is to be their zealous defender in the face of these systemic barriers, upholding not just the letter but the spirit of the U.S. Constitution's Sixth Amendment, whatever the particulars of a given case.

#### **Core Responsibilities**

- Lead and mentor 22 associate public defenders who will be responsible for delivering zealous representation to the adult indigent criminal defendants charged within Kalamazoo County.
- Establish goals and process for assigning cases.
- Identify training opportunities necessary to develop talent and satisfy continuing legal education requirements dictated by the State of Michigan.
- Define mentorship structures necessary to ensure a collaborative environment, conducive to fostering excellence in legal representation and the utmost respect for all clients and coworkers.
- Serve as counsel in the most challenging cases that are assigned to Kalamazoo Defender by the Courts of Kalamazoo County.
